INSPECTORS MAY REFUSE TO PERFORM THE INSPECTION IF THE FOLLOWING REQUIREMENTS ARE NOT COMPLIED WITH:

1. All animals presented for inspection must be **PROPERLY BRANDED** according to the required Nguni method of identification as described in the Society's By-laws.
2. Inspection lists can be drawn from **LOGIX** (Reports/Administrative reports/ Inspection list). All animals that are due for inspection will appear on this list. Make sure that all the animals you want to inspect appear on the list. If animals are on the list but are no longer in your possession, contact Liezel Grobler (liezel@nguni.co.za) to cancel or transfer the animals.
3. It is the breeder's responsibility to present the Logix inspection list of the animals that needs to be inspected to the inspectors. The Logix inspection list must be supplied to the inspectors in triplicate.
4. If an inspection list cannot be obtained, the inspection book must be filled in correctly and completely. Male, female and First Registration (FR) animals must be filled in on separate pages and birth notification certificates (where applicable) must be attached.
5. First Registration (FR) animals must be completed in an inspection book.
6. Bulls may be inspected from one year (12 months), supported with a motivation, but preferably from two years (24 months) and heifers from one year (12 months) of age. Female animals that are calf book should be inspected before the age of three years (36 months) of age.
